- 4) Per rules set by the California State Personnel Board, all applicants must submit a standard State of California application (STD 678) available at: http://jobs.ca.gov/pdf/std678.pdf

This state application should be completed online and sent to <u>Carol.Woods@dsh.ca.gov</u>, by the November 1st application deadline. STD 678 is not to be uploaded with the APPI. APPIC has approved the use of the STD 678 as an additional document for California DSH internships. (Apple Computer users should note that you may need to complete, print and then scan the form to submit. Some Apple users have found that even though the form appears complete on their computer, when e-mailed the completed form is sent blank. Don't forget to sign the document before sending it.)

The application and all needed supporting documents must be received by **November 1, 2017.** Applicants will be notified as to whether or not they will be given an opportunity for an interview by December 15, 2017. Interviews are scheduled on Fridays in January. Those who cannot appear for a personal interview will be scheduled for a video conference (Skype) or telephone interview.
