This notice announces a 15-day comment period in which the public may comment on the additional document added to the record. The Initial Statement of Reasons (ISOR) for the sexually violent predator standardized assessment protocol regulation was modified and the **Supplement** was added to the record for public comment. This notice is issued pursuant to Government Code Sections 11346.8, subsection (c) and 11347.1, and California Code of Regulations (CCR), title 1, section 44

This regulatory action was originally noticed and published in the California Regulatory Notice Register, and was also mailed on December 8, 2017 to all interested parties. - 2. Expand the necessity and need for the Sections 4012, 4013, and 4014.
- 3. Explain the necessity of section 4015 to help provide clarity based upon case law.
